

AI New Frontiers Competition Terms and Conditions

1. Introduction

Welcome to the Technology Training AI New Frontiers Digital Art. By participating, you agree to abide by these terms and conditions. This Competition is organized by Stanford Technology Training Program the "Organizer".

2. Eligibility

- The Competition is open only to individuals who are 18 years or older.
- Employees of the Organizer, and their immediate family members are not eligible to participate.

3. Competition Period

- The Competition begins on June 16, 2024, and ends on August 16, 2024 (the "Competition Period").
- All entries must be received by 3:00 PM PST on Friday August 16th, 2024.

4. How to Enter

- Participants must create an original digital artwork based on the AI : New Frontiers theme and submit it through the submit link by the End Date.
- Each participant may submit up to three entries.
- Entries must be in digital file format, e.g., JPEG, PNG, MP4 and must not exceed file size limit, of 100 MB.

5. Submission Guidelines

- Artwork must be original and created solely by the participant.
- Artwork must not have been previously published or submitted in any other competition.
- Entries must not contain any offensive, defamatory, or inappropriate content.

6. Judging Criteria

- Entries will be judged based on creativity, originality, and adherence to the theme.
- The judging panel will consist of seven judges from the technology training team.
- The judges' decisions are final and binding.

7. Prizes

- Prizes will be awarded as follows:
 - First Prize: Apple iPad
 - Second Prize: Apple Watch
 - Third Prize: AirPods
- All participants will receive a voucher for \$50 credit toward a future Technology Training course.
- Prizes are non-transferable and no cash alternatives will be offered.

8. Notification of Winners

- Winners will be notified by email within 2 weeks after the Competition Period ends.
- Winners must respond within 10 working days to claim their prize. Failure to respond will result in forfeiture of the prize.

9. Intellectual Property

- By entering the Competition, participants grant the Organizer a non-exclusive, royalty-free license to use, reproduce, and display the submitted artwork for promotional purposes.
- Participants retain all other rights to their artwork.

10. Privacy

- Participants' personal information will be used solely for the purpose of administering the Competition and will not be shared with third parties without consent.

11. General Conditions

- The Organizer reserves the right to cancel, suspend, or modify the Competition if fraud, technical failures, or any other factor beyond the Organizer's control impairs the integrity of the Competition.
- The Organizer is not responsible for any lost, late, misdirected, or incomplete entries.

12. Governing Law

- The Competition and these terms and conditions are governed by the laws of state of California.
